## Commitment Mapping to General Planning

### Fund Mapping for Transfers to Plant

With the exception of commitments with Transfer Type equal to “Transfer to Plant”, Fund will be the same for both the Source and Target. For Transfers to Plant, fund will be as entered for the Source, but will map to a Plant Fund for the Target as follows:

Source Fund	Target Fund
7000 Private Restricted Gifts	9000 Unexp plant restr gift fund
7100 Private Unrestricted Gifts	9100 Unexp plant unrestr gift fund
Other Current Funds (under 100A)	9105 Unexp plan university funds
9XXX Plant Fund	Values is the same as the Source
